INDUSTRY SECTOR CODES are used for classifying business establishments by the type of industry in which they are engaged.

NACE codes, used predominantly in Europe, and **NIC** codes, used in India, are classification systems used to track the activities undertaken by businesses. These codes are organised into a four-level hierarchical structure. The highest-level categories are called sections. The first two digits of the code indicate the division, the third digit indicates the group, and the fourth digit indicates the class.

The table below maps Industry Sector Codes with compatible NACE, NIC Division Codes.
